MECHANICAL PERMIT FEES

Permit Issuance

For issuance of each mechanical permit \$115.00

Fee Schedule

(Note: The following does not include the permit issuance fee)

Furnaces Installation

Residential;

For the installation or relocation of forced air or gravity-type furnace or burner, each \$128.00

Commercial;

For the installation or relocation of forced air or gravity-type furnace or burner, each \$256.00

For the installation or relocation of suspended heater, recessed wall heater, floor furnace, or floor mounted unit heater including flue vent, each \$192.00

Appliance Vents and Ducts

For the installation, relocation or replacement of appliance vent, ducts, per system \$192.00

Condensing units (AC), each \$128.00

Boilers, Compressors & Absorption Systems

For the installation or relocation of each boiler, compressors 1 - 15 horsepower, or absorption system 0 - 500,000 Btu/h, each \$192.00

For the installation or relocation of each boiler, compressors 16 - 50 horsepower, or absorption system 500,001 – 1,750,000 Btu/h, each \$256.00

For the installation or relocation of each boiler, compressors 51 and over horsepower, or absorption system 1,750,001 and over Btu/h, each \$320.00

Air Handlers

For the installation or relocation of air-handling unit, each \$192.00

Evaporative Coolers

For each non-residential evaporative cooler other than portable type, each \$256.00

Ventilation & Exhaust

Residential;

For ventilation fan or hoods connected to a single duct, exhaust fan for bathrooms, kitchens, or laundry rooms, each \$192.00

Commercial;

For the installation of kitchen hood each which is served by mechanical exhaust, including the ducts for such hood, each \$512.00

For ventilation system which is not a portion of any heating or air-conditioning, each \$256.00

Incinerators

For the installation or relocation of each commercial or industrial-type incinerator, each \$768.00

Repairs or Additions

For the repair, alteration, or addition to each heating appliance, refrigeration unit, cooling unit, absorption unit, or evaporative cooling system, including installation of controls, each \$192.00

Miscellaneous

For each appliance or piece of equipment regulated by this code but not classed in other appliance categories, or for which no other fee is listed, each \$256.00

Other Fees Collected With Mechanical Permit:

Long Range Planning Fee: 15% LRP fee to be added to mechanical fee total.

GIS Technology Fee: 5% GIS Tech fee to be added to mechanical fee total.
